WILL HART WITH IDAHO CONSUMER-OWNED UTILITIES ASSOCIATION MUTUAL ASSISTANCE AGREEMENT – Action Item. 7:23:48 PM

Will Hart, Executive Director of the Idaho Consumer Owned Utilities Association of which the City of Weiser is a member. ICUA represents (11) eleven rural electric cooperatives and (10) municipal power company's across the State of Idaho and serves about 140,000 consumers and member owners across the State. My job is to represent you at the State, Regional, Federal and International level on issues relating to energy, Bonneville Power Administration and such. I am happy to answer any questions you might have about that, but I'm here tonight to talk to you about the Mutual Assistance Group and ask you to join. In August of 2017 the majority of utilities in Idaho signed on to the Idaho Mutual Assistance Group. This is a voluntary organization that was formed so that our utilities can help each other out in times of disaster. We got almost everybody to sign on and through some paperwork glitches we realized we had some members that had not signed on yet, and the City of Weiser is one of them. I reached out to Clerk Tate and asked for some time to talk to you and ask you to sign on to the IMAG Agreement. We thought that there may be some concerns that the Agreement was codified back in 2017 and now it is 2022. Well, there have been no changes to the Agreement and as we have added utilities over the years they have just dated their signatory page to the date and month of signing and provided us a contact at your utility and then you are a member of the Assistance Group. With that I am happy to answer any questions on the IMAG or ICUA issues, Bonneville, anything going on in the State House, if not, I just humbly ask for you to sign on and join the rest of the utilities in Idaho, protecting you and helping protect them.

7:26:58 PM – Mayor Hibberd, I've read the contract, but what is the intent in your words? Will Hart, mutual assistance agreements are very common across the country and in Idaho we've had a couple over the years, some involved just a few utilities along with their neighboring investor owned neighbors. We really made a concerted effort back in 2017 to more accurately formalize this group. Especially in expectation, we never want it to happen but we know it has happened, whether it's flooding, wind, snow, disasters, fire...we want to make sure we had an actual process that was easy to follow moving forward and that we had an agreement that stated, that everybody could agree to, here's how we're going to reimburse each another, here's how employee's are defined, here's the process that you go through if a disaster happens. It's almost like an old phone tree, you start with the first name on the mutual assistance group if you can't reach them you go the next one. As soon as you get that person the IMAG meets on a conference call and decide what is needed. Your contact gets together with the IMAG contact and we move forward from there. Really the purpose is to make this Mutual Assistant easier, more accessible and for our contacts to know who each other are in the time of disaster.
