[7:04:02 PM](#) – Sterling Blackwell, Library Committee Report. That's kind of one of the things that they're trying to put together to make it fit, kind of in the interim. They haven't really got a cost analysis and some of that kind of thing taken care of yet, but it should be formalized probably in the next month or so.

APPROVE BID \$1,038,000 FOR WATER RESERVOIR REHABILITATION – Action Item.

[7:13:25 PM](#) - Bill Taylor, Water Department Supervisor. We started this project last year at the beginning of our budget period and we got an estimate from our engineering to how much it was going to cost and we estimated the cost to be \$560,000.00. We went out to bid this Spring and we got two bids in, one was for 1.038 and one was for 1.9 million dollars. We had our engineers talk to several paint contractors to find out why it was a lot over our estimate. A lot of it was that paint costs have extremely gone up, our rules for guarding paint mixtures for water have also changed. They've gone to a new formula to where it has less toxic metal in it and all of that. That has increased paint costs exponentially and also all the freezing that happened down in Texas last year and Covid and supply chain issues have really driven it up. We talked about rejecting the two bids that we got and maybe going out to bid next year and supplement our budget. Talking to the engineers and painting contractors, it's not going to get any cheaper. We're looking at maybe 1.3 to 1.6 million dollars, so we are looking at trying to accept this bid. We did have in our budget, we were to use our America Relief Infrastructure Act Money out of our current budget. Talking to the bidders, they would be willing after October 1st to accept a final payment after that. If we accept this bid we would have to adjust our budget for next year to pay off the rest of this amount.

[7:15:34 PM](#) – Mayor Hibberd, how much would a new water tank cost? Bill Taylor, at this point, a million and a half gallon steel bolted reservoir, you're probably looking at 3 to 3.5 per gallon, so probably three to four million dollars to replace. This Reservoir was built in 1953 I believe, it was totally re-coated on the interior probably in the 70's from what I can tell. It's time to do something to it, I don't believe delaying is the best option, I think we just need to move forward and get this done and then we will be set up. We have already done Reservoir #2 which is a sister reservoir just like that up on Chicken Hill, it's complete inside and out. This particular bid will complete #1 inside and out. They will totally have to sand blast the interior of it down to bare metal, do a bunch of structural on the inside on the rafters where there's been some corrosion issues. We definitely don't want to have collapsing issues with that, so we need to address this sooner than later. I think now is the time to do it, if we can.

[7:16:54 PM](#) – Larry Hogg, it was redone in the 70's is that right? Bill Taylor, I believe so, I haven't found any permanent documentation, but I believe when Reservoir #2 up on Chicken Hill was built the exterior was probably coated and re-coated and the interior was re-coated back then at that time. Larry Hogg, so can we expect that this will be good for the next fifty years? Bill Taylor, I would hope so, with continued maintenance, yes. If we don't, it won't be.

7:17:24 PM – Layna Hafer, help us all understand again, obligating funds out of next years budget. Mayor Hibberd, we have the funds already, they came to us in the form of ARPA Funds. Mike Campbell, so they've been split up between Wastewater and Water which is not necessary, it's just the way we put the money away. So we do have the funds available for next year to put in the ARPA lines. It should be 100% covered out of ARPA funds at this time, we would have to move about \$510,000.00 in what we have of ARPA funds back over to finish this up next year. We just don't have the spending authority to do it this year, so we split the spending authority between this year and next year.

7:18:17 PM - Mayor Hibberd, I believe the funds were actually budgeted in the Wastewater and the Water and so we have the spending authority out of both places, we just need the extra time to move it over to the Water Department.

7:18:40 PM – Sterling Blackwell, what was the purpose that we split the two, because I thought there were major projects that needed done in both departments? So then, what project are we going to be putting on hold? Mike Campbell, so we have been looking at moving the 7th Street Sewer Main and attaching it where we've done Galey going north, so where Galey ties in behind the Institute, we've redone that whole line going north. We were going to bring that over into 7th and run it down the road where they paint the street instead of out in the middle of that field. When they bid it last time it was going to be a lot less expensive project so it seems more valuable to do something that is a necessity now. The Wastewater we can do over the next few years if we have to. We are looking at cost again and getting updated cost on that, you're probably about \$300,000.00 to \$350,000.00 is what they estimated the first time, depending on what's in the ground, and we don't know. I believe that it would be best to move this money over and take care of this water reservoir. We are in the millions to do this, the roof of that thing is structurally becoming deteriorated faster because it sits in water all the time, if we don't get it fixed and resealed up it could be a problem sooner than later.

7:20:07 PM – Mayor Hibberd, and be a more expensive problem, and we do have the funds in reserve on the Sewer Department.

7:20:17 PM – Layna Hafer, my only question in that is, to me it seems like it's a project that we need to, we need to approve next years budget, and then authorize the funds to be released this year because, we wouldn't have it in our budget yet.

7:20:36 PM – Bill Taylor, they won't have to be released this year because by the time they get here and start working on it they won't have the project done by October 1st so they will actually get their final payment out of next years budget. However, because the fact that the ARPA funds are already authorized to spend out of both departments this year, we could pay for them out of this years budget, just, it would come out of the Sewer and the Water. Layna Hafer, I totally understand that, it's just if we go into next year authorizing that expenditure where a budget hasn't been approved, I think we have to approve the budget before we can authorize the expenditure.

7:21:16 PM – Mayor Hibberd, I don't think so, we authorize the purchase of trucks for the Electrical Department where we know it wasn't going to be spent this year, it's going to be spent in future years, but we had to take and authorize that in order to take and get the process going, to order it. It's the same way with this, we have to take and get the authorization now to start the work.

7:21:51 PM – Mike Campbell, the other issue is if we wait that long we have to go back to bid, the ninety days would be up on it. Because we thought this would come in 40% less, where it's so much higher. The Engineers, we did do our due diligence, we did check all over, the next closest one was Long Painting, which has done how many of our reservoirs? and they said they wouldn't do it for less than 1.3 just for what we told them, without even looking at it. Bill Taylor, now's the time to act on it. Mike, we do have the funds to do it even out of this budget, we would just have to do it out of Wastewater which would be...I'd rather not. Mayor Hibberd, we just don't have the spending authority in the Water Department at this time, that's not to say we won't have.

7:22:48 PM – Layna Hafer, it just means that we have to approve this when we do our budget. Mayor Hibberd, it would have to be included in it, yes, and it's already added in there. Layna, I know, just saying, we're kind of hedging our...if we had a huge emergency and money got shifted out of there that's ...

7:23:04 PM – Bill Taylor, also to think about, not that it's ARPA money, but we budgeted last year to pay off one of our loans but with all the interest rates increasing we never paid off that loan that we actually had in our budget to pay off. About \$500,000.00 of savings to cover that and this would do the same thing, it just wouldn't be ARPA money. So with our savings and or the ARPA it could be done.

7:23:30 PM – Mayor Hibberd, our interest rate was like 1 or 2% and at the time interest was paying about .0003 and it flipped, so we decided not to pay that off and we've been gaining some pretty good returns this year.

7:23:56 PM – Sterling Blackwell, I just want to make sure we knew which projects were being pushed to the side to make space for this one.

7:24:18 PM – Mayor Hibberd, the whole inside has to be sandblasted and there is lead in there so it has to be removed properly. Bill Taylor, the old paint, when they put it in, that was the common factor but it's sequestered in there. It's not lead leaching into the water at all, but once you start sand blasting it you have use a special media and dispose of it in a proper way. Larry Hogg, it's once you disturb it then you...Bill Taylor, that's when you start having problems. When they start the process that thing will be completely emptied, they will actually do what they did on the other reservoir, cut a big hole in the side so they can get equipment in there and go to town sandblasting. It will be quite a process to see when it gets going.

7:25:00 PM – Sterling Blackwell, how much time do they think for that project to be completed, what's the estimate? Bill Taylor, probably six months I'm thinking, wasn't it Mike? Mike Campbell, they asked for 180 days. Bill, we will still have our other reservoir, and we will just have to keep our Plant running, but this time of year it's real easy to do, the water demand is up so we just keep it running.

FIDDLE FESTIVAL UPDATE. 7:27:35 PM

No one from Fiddle Festival attended tonight's meeting. Mike Campbell, all of the Fiddle Festival activities will be at City Park this year. There will be no Fiddle Festival stuff at Memorial Park this year, where they didn't have the carnival coming in they decided that with more trees and everything at the City Park, so it will all be located between 2nd and 4th and Liberty and Court Street.

7:27:59 PM – Layna Hafer, so are all of the Power Boards back at City Park? Mike Campbell, we will put them back in.

APPROVE DEVELOPMENT AGREEMENT MAVERIK PROPERTY – Action Item.

7:28:14 PM – Mayor Hibberd, if you will remember when we approved the annexation, we approved with the condition that there would be a Development Agreement. We received that, it's been reviewed by our attorney and they're OK with it.

7:28:49 PM – Larry Hogg, I have a couple of questions. It refers to a couple of exhibits that at least were not included in my copy of it, Exhibit B, C, D, and E and F. Layna Hafer, and G. Clerk McDaniel, I printed what you sent me. Mayor Hibberd, I will have to check into that. Council Members took a couple minutes looking at what the Exhibits referred to in the D.A.

7:30:13 PM – Sterling Blackwell, I don't have those exhibits in front of me but I can at least give you an update on what the Design Committee was negotiating with Maverik to give you some idea of what is included in those. The Design Committee had submitted concerns about coloring and the type of signage and even some of the landscape options that Maverik had proposed. Maverik to my knowledge agreed to the changes we proposed. Those changes included: (1) Signage, instead of a 30 or 35 foot pole in the air they agreed to go with a Totem which is ten feet if I recall. Originally we were hoping for something closer to the ground but ITD had issues with sight lines. (2) The Coloring, they chose to go with more natural coloring that is going to match our fona in our area. (3) They have also agreed to change the facade of the buildings on I believe have more natural timber and stone along it so it will look more natural and less commercial steel building. (4) Landscaping, some of the landscaping ideas that we had presented was to match the fona with things that are more natural and pleasing to the eye but also a little more hearty for what we have here in our natural area and they agreed to those as well. I'm sorry that you don't get to see those things, but that's what we worked on and they agreed to that, I can tell you that.

7:31:53 PM – Mayor Hibberd, I know that on Exhibit B, the improvements for the road and the sidewalk have been approved by ITD. Exhibit C which is for the water going underneath the river which we have those plans and the engineers looked at them. Larry Hogg, and we're OK with those? Mayor Hibberd, yes, our engineer is.

7:32:33 PM – Mayor Hibberd, Exhibit D, Landscaping. Sterling Blackwell, we already talked about. Exhibit G, Signage dimensions, materials and colors which were also already covered.

7:32:51 PM – Layna Hafer, is there a possibility that those could be printed and left here so that if we wanted to come in and see where the changes are, because I think we met and reviewed the big plans and I just want to see more. Clerk McDaniel affirmed.

7:33:15 PM - Mayor Hibberd, Maverik has been very cooperative but they would like to get moving on this project.

7:33:27 PM – Sterling Blackwell, I can confidently say that they have been great to work with and the design committee which has very strong personalities in that group are all very happy with the changes they have accepted and changed. We were very excited at all the changes they accepted and it gave us the ability to kind of put that to the side and then channel those into what our guidelines would be.

7:34:11 PM – Larry Hogg, item 13 says the owner will dedicate to the City a twenty foot wide strip of land and then we'll be responsible for basically the maintenance of that area, so I'm just wondering about the cost of that maintenance and what we're agreeing to here. Mayor Hibberd, it's an easement so that in case we ever put in a bridge to bridge walking path that property is available. So if that ever happened we would take over the maintenance of it. Sterling Blackwell, that's how it's zoned Larry, just so you know, like in the original development plan there was that easement put in that zone. So both Development Plans have an easement on both sides of the river. Larry, this is saying to me that we will take on the maintenance of it now, is that correct? Sterling, it's our property. Mayor Hibberd, it's mainly down by the river and so it won't be developed at this time. Larry, so it's not like the weeds are going to grow four feet high that everybody can see that we have to...Clerk McDaniel, it's not something that's going to be like mowed, like on the edges of the parts of town. Cliff Barberis, we don't care about it now anyway. Larry, according to this we will be. Mayor Hibberd, once it's developed as a walking path. Sterling, this is their way of saying they are not going to touch it. Larry, my concern was that we were biting off a big expense here. Mayor Hibberd, no, I'd have the Street Department up in arms if I did that.

APPROVE DEVELOPMENT AGREEMENT PARKER AND PARKER CAMPGROUND –

Action Item 7:36:53 PM – Mayor Hibberd, when the property was annexed into the City it was with the condition that we have a Development Agreement and we have that now and it's been looked at by our attorney and theirs and everyone's copacetic.

7:37:34 PM – Larry Hogg, one question on this one, items 3.5 and 3.6 say they can't operate in January, February and December of each year and the utilities will be shut off and capped for those months. I'm just wondering, what happens if the flood doesn't come until March?

7:38:17 PM – Mike Campbell, we actually looked at that, December, January and February are probably the worst months because it's flooded by ice jam which is very unpredictable, like you can't see it coming. The March floods that do happen all the way through May, I mean it's not uncommon. What we did was we added them up and took a tally of the high marks. December through February were by far the worst months with unpredictable flooding. In March we can predict it about eight to ten hours out to move people. That's because we know what the water is running in like Cambridge and Midvale, we have a time of between eight to twelve hours depending on the volume to predict that the water is raising that fast. It was kind of hard because we did pick three months and it was like limited to a three month window and those were the worst three for an ice jam to flood immediately, I mean you have no warning, so that's why we picked those months.

7:39:17 PM – Larry Hogg, so that's why they have that in here, because it can happen just like that, a snap of the finger. So if we have eight or ten or twelve hours notice we can make whatever arrangements need to be made to keep everybody safe and our system safe? Mike Campbell, yes. As far as the system goes, everything that's in there even like the sewer, all that has to be done is the pump shut down because it will be a pressurized sewer system. It could fill their lines completely and it wouldn't pump through with the pump off. Even if they left the caps off, like had to hurry, as long as we shut the pump off it won't put any of that water into our system.

Bob Barrow did not attend to tonight's meeting. Mike Campbell, Bob Barrow is not here and I'm not sure what we can do. I will have to contact him in the morning, but he was aware of the meeting. I don't know if he's gone due to circumstances or what.

7:41:45 PM - Larry Hogg, is his due date coming up? Mike Campbell, it is this month. Mayor Hibberd, it was on June 1st. Mike Campbell, so he wanted to extend it, they're having issues. They've had water leaks and elevation grade issues, a few set backs.

7:42:05 PM – Layna Hafer, is it possible Mayor since we are meeting in June again, after our budget hearing that we could go ahead and have a meeting in June for that? Mayor Hibberd, we could. Mike Campbell, I will contact him and let him know.

7:42:23 PM - Larry Hogg, what happens if we go past the due date? Mike Campbell, I think we could do a stop work order if we so wanted to. I don't know if they'll be doing any more work or repairing what's there. Larry, does it cause him to have to reapply and go through the whole process? Mike, it could, if you guys wanted to do that you could make him do the whole application again instead of extending his plat. Larry, OK, but do we have the option of not having him do that as well, even though the date has past? Mike Campbell, I believe so, the way it's in there it just says it must be renewed as you're guy's thing after the first year. After the first year it needs to be brought in front of you to ask for extension. Mayor Hibberd, and he asked for one extension already. Mike, he did, for six months. Like I said they've had a lot of engineering issues out there I will give them credit on that, but the water issue they pressurized the system and then it leaked down. They have three leaks maybe four, so they are digging those up right now trying to find them because it's not surfacing so it's been taking quite a bit of time. Then their elevation grades were not correct for the road so they have had to come out and re-shoot every elevation on top of what they've done already. Larry, I was just wondering does it make sense for us to extend it for thirty days or can we even do that without a request? Mike, honestly I don't know the answer to that. Layna Hafer, he needs to submit a request. Larry, I guess he's a big boy and he knew when the due date was right? and he knew when the meeting was. I don't want to cause him a lot of trouble that's unnecessary, but...Layna Hafer, in a case like this if it came down to, and I'm just filling in here, should there be some critical financial or filing thing, the Mayor could call an emergency meeting for the Council and we could deal with it. Larry, OK. Mike Campbell, I will get him here for the next meeting or make sure to remind him that he wasn't here today.

SWIM TEAM REQUEST TO USE CITY PROPERTY – Action Item. 7:45:13 PM

City Clerk Natasha McDaniel, it's kind of rare because our pool and pool area is so small that we have a swim championship meet like this where there will be five to six teams actually meeting here which is kind of really cool. So the Swim Team parents and just some people who were involved wanted to kind of make a little event out of it where they would allow parents and anybody to park and then right there by the Pool from Hanthorn just on 3rd Street there where it's already pretty much blocked off, they would just add a couple more cones so that nobody could drive in there once everybody is parked. They want to do it one of two ways or maybe a little of both. The reason they are coming to Council to ask for permission is because they are wanting to have food vendors, one to three, however many they can get and or just have Moms and Dads with grills selling hot dogs and hamburgers something small like that, just because there will be a larger number of people there. This is with the understanding that the proceeds from what is made will go back to the Swim Team. So a little bit of a fund raiser, a little bit of get involved with the community. Like I said it's not very often that our Pool gets to host a championship meet.

7:46:47 PM – Larry Hogg, I was a little unclear, so right beside the Pool where that barricade is we're going to close that clear off, then it says something about to the Green House. Clerk McDaniel, so right there where it turns west where the softball fields are and it would go up and meet State Street, so basically it's just that little block right there.

7:47:16 PM – Layna Hafer, I think, and correct me if I'm wrong, we block that off during Fiddle Week in the past just for safety anyway. Larry Hogg, I was just a little unclear, so is it going to be blocked off clear to State Street? Clerk McDaniel, no just right to where it curves to head west. Larry, so if I turn off State Street on...Clerk McDaniel, on Hanthorn and come down and hit that stop sign and if you were going to try and turn north, it's already blocked off with barricades, you would just completely block that off and as you're driving north before you turn to go west, just that little block there is going to be blocked off, it's already blocked off. Larry, but if I'm coming from State Street and I head down that road, Mike Campbell, Gray Ave. Larry, where am I going to go when I go “oh gosh that road's blocked off” where do I go? Mike Campbell, we will put “Road Closed” signs at W 2nd.
