Commission Reports:

7:02:45 PM – Sterling Blackwell, Library Report. In November there were 3,205 check outs, 3,672 patrons came in, 17 new library cards were issued, 67 library cards were renewed and 400 new books went into rotation. The 2023 Christmas Open House was a great success, 242 guests came in on Saturday, 255 on Friday and 223 on Thursday. The Library Board is working on updating their Policy Manual. On February 1st the "Lets Talk About It" will be on Billy Lynn's book, The Last Halftime Walk by a professor from BSU. The Library received a \$2,000.00 Grant for the Summer Reading Program, they are already getting enrollment started for that.

<u>7:04:09 PM</u> - Layna Hafer, Economic Development Report. They have filed their Nonprofit paperwork and have a Nonprofit EIN. A Board has been established for the Main Street Weiser Program. They will be meeting tomorrow to discuss a wider identification of exactly what the Main Street is going to encompass.

All our people want to keep it in Weiser, all our Pullers love coming to Weiser and it supports local businesses, so we would like to keep it here.

INCREASE IN MEAL PER DIEM – Action Item. 7:23:41 PM

Clerk McDaniel, currently the Per Diem for meals is \$15.00 for Breakfast, \$15.00 for Lunch, \$25.00 for Dinner with a total in a day of \$55.00 and currently the employees are responsible for gratuity. We send employees all over for training and it is almost impossible to find a lunch for \$15.00.

Chief Smith, we send guys to the Boise area all the time for training and those figures are just unrealistic in this day and age. Clerk McDaniel, our proposed increase is \$20.00 for Breakfast, \$20.00 for Lunch and \$30.00 for Dinner, total of \$70.00 per day. In addition, we would like to add that they are allowed to leave a 20% gratuity.

<u>7:25:07 PM</u> – Sterling Blackwell, how does this affect any money you have budgeted for training? Chief Smith, it still comes out of what each department has set aside for training so that money is already there. It is just authorizing it to be used for meals.

<u>7:25:30 PM</u> – Clerk McDaniel, we also ask that if the Chief sends an officer or the City sends an employee somewhere and as a group they go out to a more expensive restaurant, that their Per Diem for that day would not cover, that with their Supervisor's signature and approval it would be OK to go over that Per Diem for that meal. Chief Smith, a great example of that is when we send an officer to Sun Valley.

This is just a general guideline of 48 hours for no symptoms for the safety of employees at work and the employee that's at home.

Discussing this with Clerk McDaniel we decided to just say elected officials, since Council Members are elected officials. We will take that out of all the policies.

Mayor Hibberd, we are trying to speed the process along, we have received notification that we will probably be awarded \$2,000,000.00 to repair East Commercial Street. It has to go before the ITD Board for final approval. We have had previous projects where engineering has taken some time and ended up in the middle of construction season trying to obtain bids. This is an effort to try and get the engineering contract approved ahead of time so we don't have to wait for another meeting for them to get started. In the Grant they allow 15% for engineering which is \$300,000.00. We don't expect it to come to that because the engineering on the bridge part of it has already been done. So we are looking at approving up to the \$300,000.00 so we can get going on the project and move it along and be at the right time of the year for the bidding process.
