

## **RESOLUTION #694**

At a regular meeting of the Council of the City of Weiser, Idaho, On November 12<sup>th</sup>, 2024, the Council discussed fees, charges, responsibilities and penalties for Fry Foods, Inc., and the issuance of an Industrial Wastewater Acceptance Permit.

Motion was made by Councilperson\_\_\_\_\_ and seconded by Councilperson\_\_\_\_\_. And it was resolved that the following fees, charges and responsibilities be adopted and apply within the Industrial Wastewater Acceptance Permit and further authorized the Wastewater Superintendent to sign and issue an Industrial Wastewater Acceptance Permit to Fry Foods, Inc.

The fees to be paid by Fry Foods, Inc. to the City of Weiser are made part of the Industrial Wastewater Acceptance Permit and shall be as follows:

1. Indirect costs, which include the fees for the lab expenses and upkeep of the sampling station shall be at actual cost.
  
2. Direct costs based up the following criteria will be at the following rate:
  - A. Flow charges will be billed at a rate of \$1236.00 per million gallons per month.
  
  - B. B.O.D. 0-600 lbs. will be billed at \$.3255 per pound daily  
B.O.D. 601-700 lbs. will be billed at \$.3675 per pound daily  
B.O.D. 701-800 lbs. will be billed at \$.7455 per pound daily  
B.O.D. 801-900 lbs. will be billed at \$1.47 per pound daily  
B.O.D. 901-1000 lbs. will be billed at \$2.7615 per pound daily
  
  - C. T.S.S. 0-600 lbs. will be billed at \$.483 per pound daily  
T.S.S. 601-700 lbs. will be billed at \$.588 per pound daily  
T.S.S. 701-800 lbs. will be billed at \$.777 per pound daily  
T.S.S. 801 lbs. and above will be billed at \$.4.389 per pound daily
  
  - D. Potential Hydrogen (ph) Standard Units (S.U.) will be charged at \$6.4575 per one-tenth (1/10<sup>th</sup>) S.U. below 6.5 and over 9.0 for four (4) consecutive fifteen (15) minutes periods and more.
  
  - E. F.O.G. (Fats, Oils, Grease) There will be a \$3.15 per mg/L charge for F.O.G. that exceeds the 100 mg/L daily limit. Based on actual tests.

F. Fry Foods Inc will be charged \$100.00 per hour for Jetter truck and labor to clean downstream City owned sewer mainline as the result of odor complaints. First cleaning annually will be free of charge.

3. The city operates under NPDES Permit. Should that permit or any state regulation require phosphorus loading, reduction or removal, Fry Foods, Inc. shall have thirty (30) days from the notice by the City to comply with the new regulation or permit requirement. Fry Food, Inc. shall deliver to the City of Weiser a written phosphorus reduction plan by November 30<sup>th</sup>, 2024.
4. For other pollutants which are above the limit set by the Wastewater Discharge Permit limits pages 1A and 1B of the permit, the administrative and civil penalties of Weiser City Code 7-6-6 shall apply.
